
High efficiency, three-digit LED Numeric Display ROHM LB-603 FP Series Datasheet






Fig.1 Forward Current vs. Forward Voltage





Fig.3 Relative Luminous Intensity Fig.4 Ratio of Maximum Tolerable Peak Current vs. Case Temperature vs. Pulse Duration (I) 1.6 10 l_F peak Max LB-603MF I_F= 10mA I_F Max LB-603MP 1.4 is Intensity 1.2 50kHz-20kHz 500Hz 200Hz 10kHz-100Hz Current to Maximum Forward Current 5kHz 1kHz 2kHz Ratio of Maximum Tolerable peak Rel 0.6 1 0.4 15 25 55 65 75 35 45 1 10 100 1000 10000 -25 -15 -5 5 Case Temperature : T_C [°C] Pulse Duration : tw [µs]
