







### Fig.1 Power Dissipation Derating Curve




Fig.2 Maximum Safe Operating Area





Fig.6 Typical Output Characteristics(II)




Fig.7 Breakdown Voltage vs. **Junction Temperature**





Fig.8 Typical Transfer Characteristics






### Fig.9 Gate Threshold Voltage vs. Junction Temperature




Fig.13 Static Drain - Source On - State Resistance vs. Junction Temperature





Fig.15 Static Drain - Source On - State Resistance vs. Drain Current (II)


Resistance vs. Drain Current (IV)




Fig.21 Dynamic Input Characteristics






Fig.22 Source Current vs. Source Drain Voltage


