The reverse loss of the diode might increase as temperature increasing that causes heat-up and further IR. This phenomenon might end up the thermal destruction(thermal runaway). 






trr DISPERSION MAP

REVERSE RECOVERY TIME:t_{rr}(ns)









REVERSE POWER DISSIPATION:P_R(W)







