






Fig.2 Drain Current Derating Curve









Fig.5 Breakdown Voltage vs. Junction Temperature

Fig.6 Typical Transfer Characteristics






Fig.7 Gate Threshold Voltage vs. Junction Temperature




Fig.9 Static Drain - Source On - State Resistance vs. Gate Source Voltage

Fig.10 Static Drain - Source On - State Resistance vs. Junction Temperature





Fig.11 Static Drain - Source On - State Resistance vs. Drain Current (I)

Fig.12 Static Drain - Source On - State





Fig.14 Static Drain - Source On - State Resistance vs. Drain Current (IV) Fig.15 Static Drain - Source On - State Resistance vs. Drain Current (V)




Fig.16 Typical Capacitance vs.






Fig.18 Source Current vs. Source Drain Voltage


