



Directional Characteristics ^{2), 3)}









Photocurrent/Open-Circuit Voltage ^{2), 3)}










Dark Current ²⁾




Power Consumption





Dimensional Drawing⁴⁾



Recommended Solder Pad⁴⁾




Pad 1: anode

Notes

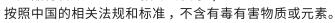
