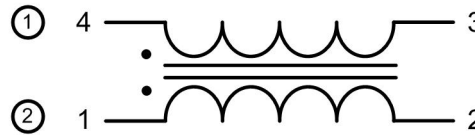

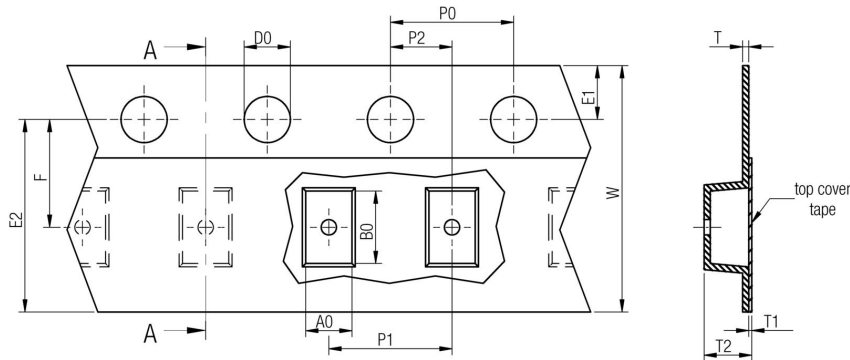
**F1 Typical Differential Mode Insertion Loss Characteristics:**



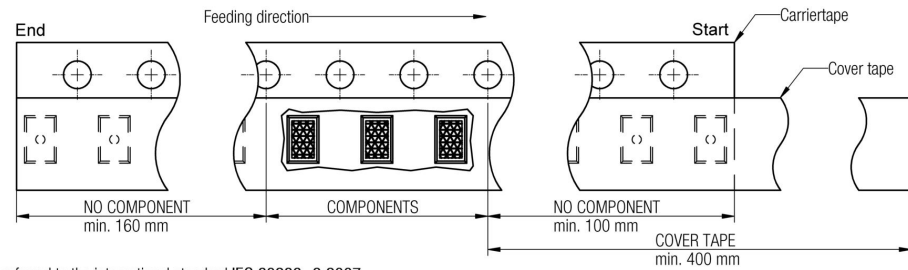
