





# **Q-factor vs. Frequency:**




# **Typical Temperature Rise vs. Current Characteristics:**

Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component, body, pins or termination.


Direct mechanical impact to the product shall be prevented as the core material could flake or in the worst case could break.

### **Product specific:**

- The soldering profile has to be complied with according to the technical reflow soldering specification, otherwise this will void the
  warranty
- Reflow soldering is not applicable. Wave soldering is recommended.
- All products shall be used before the end of the period of 12 months based on the product date code, if not a 100% solderability can't
  be ensured.
- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
- Due to heavy weight of the component, strong forces and high accelerations might have the effect to damage the electrical connection
  or to harm the circuit board and will void the warranty.
