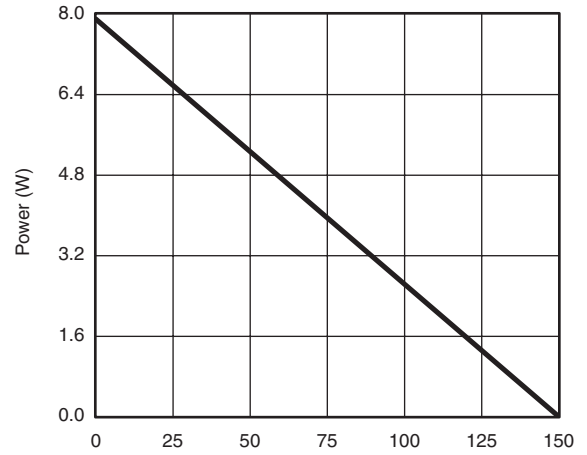

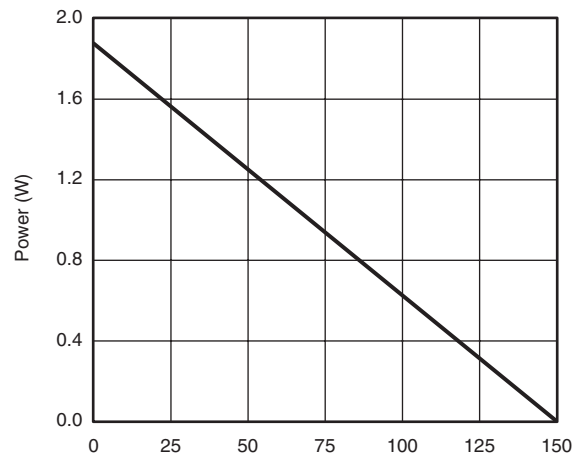
T_C - Case Temperature (°C)

T_C - Case Temperature (°C)

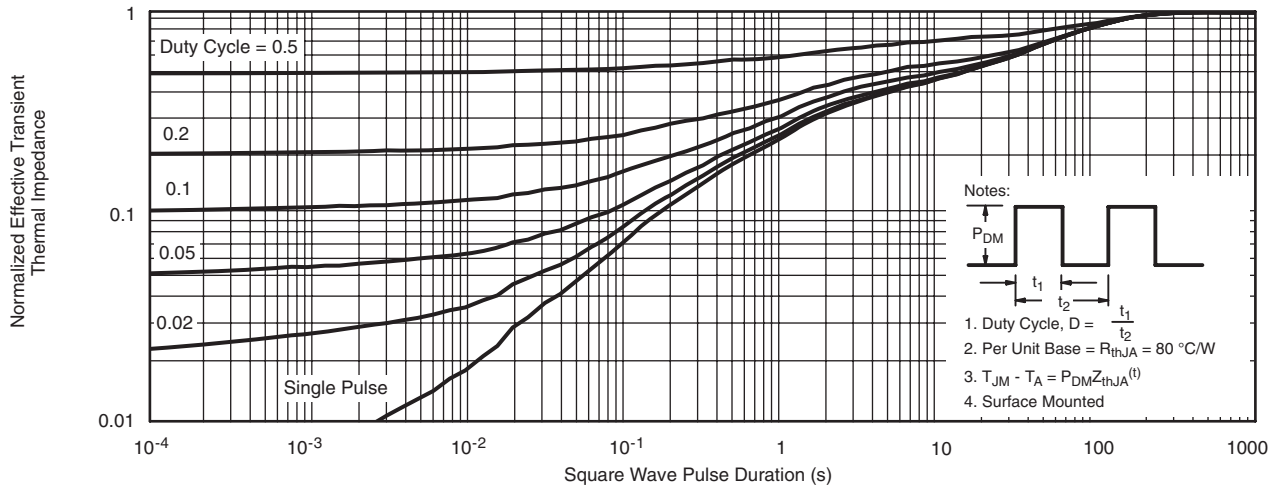
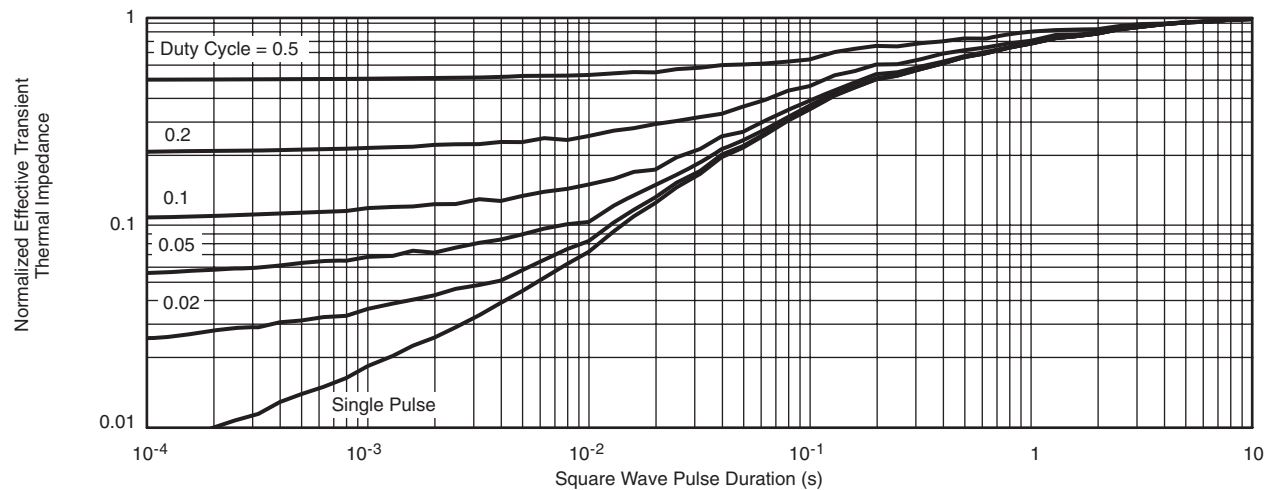
Power Derating, Junction-to-Foot
